International business aviation specialist PrivatAir announced today that it had continued with solid expansion in the past five months, adding five aircraft to its charter and managed fleet and appointing eight operations and sales team members to its U.S. Regional Headquarters in Stratford, CT.

The further development of the operations in the charter market, aimed at providing solutions for any private jet travel requirement, include additions such as a Gulfstream 550 based in Raleigh, North Carolina, an Embraer Legacy based in Sarasota, Florida, a Falcon 2000EX based in Boca Raton, Florida, and a Hawker 400XP and King Air 350 based in San Juan, Puerto Rico. These five aircraft, representative of the full range of aircraft currently available on the charter market are all late models, further decreasing the average age of PrivatAir's already impressive fleet.

Not only are we assuring different options with these aircraft, but we are able to continue our geographic coverage of the North American market."
